



Install 5-foot wide sidewalk only ~ \$30.00 per linear foot

Remove existing 5-foot wide sidewalk and install new sidewalk ~ \$35.00 per linear foot

Remove existing curb and install new curb only ~\$37.00 per linear foot

Remove existing curb and 5-foot wide sidewalk and replace curb and sidewalk ~ \$59.00 per linear foot

Install 8-foot wide sidewalk only ~ \$60.00 per linear foot

Remove existing curb and sidewalk and install new wheel chair ramp ~ \$1,750.00 each

Remove existing trees ~ \$1000.00 each

Relocate existing telephone pole ~ \$1,500.00 each
