- There are two open Community Assembly liaison positions: the non-voting liaison membership on the new city **Transportation Commission** and the voting liaison membership on the city's **CHHS Board** (Community Housing and Human Services) which became vacant only on Wednesday of this week. - The Climate Resilience and Sustainability Board has been established to provide advice and recommendations to the Mayor, City Council, and community on the actions necessary to achieve the community's sustainability and climate goals consistent with the City's Comprehensive Plan, Sustainability Action Plan, environmental stewardship policies of the City as adopted by the City Council, and within the requirements and parameters outlined in state law. The first Climate Resilience and Sustainability Board meeting has been scheduled for **Thursday, Dec. 12 from 2 to 4 p.m.** in the City Hall Council Briefing Center.
- For awareness: request for agency comment is open for the Ash Place development, which proposes to subdivide 1.32 acres near Drumheller Springs into 21 lots and build townhomes. Project information is here: <https://my.spokanecity.org/projects/ash-place-preliminary-long-plat/>. After the agency comment period is over, there will be a public comment period. This proposed development is within the boundaries of the Audubon neighborhood close to the boundary with Emerson-Garfield.

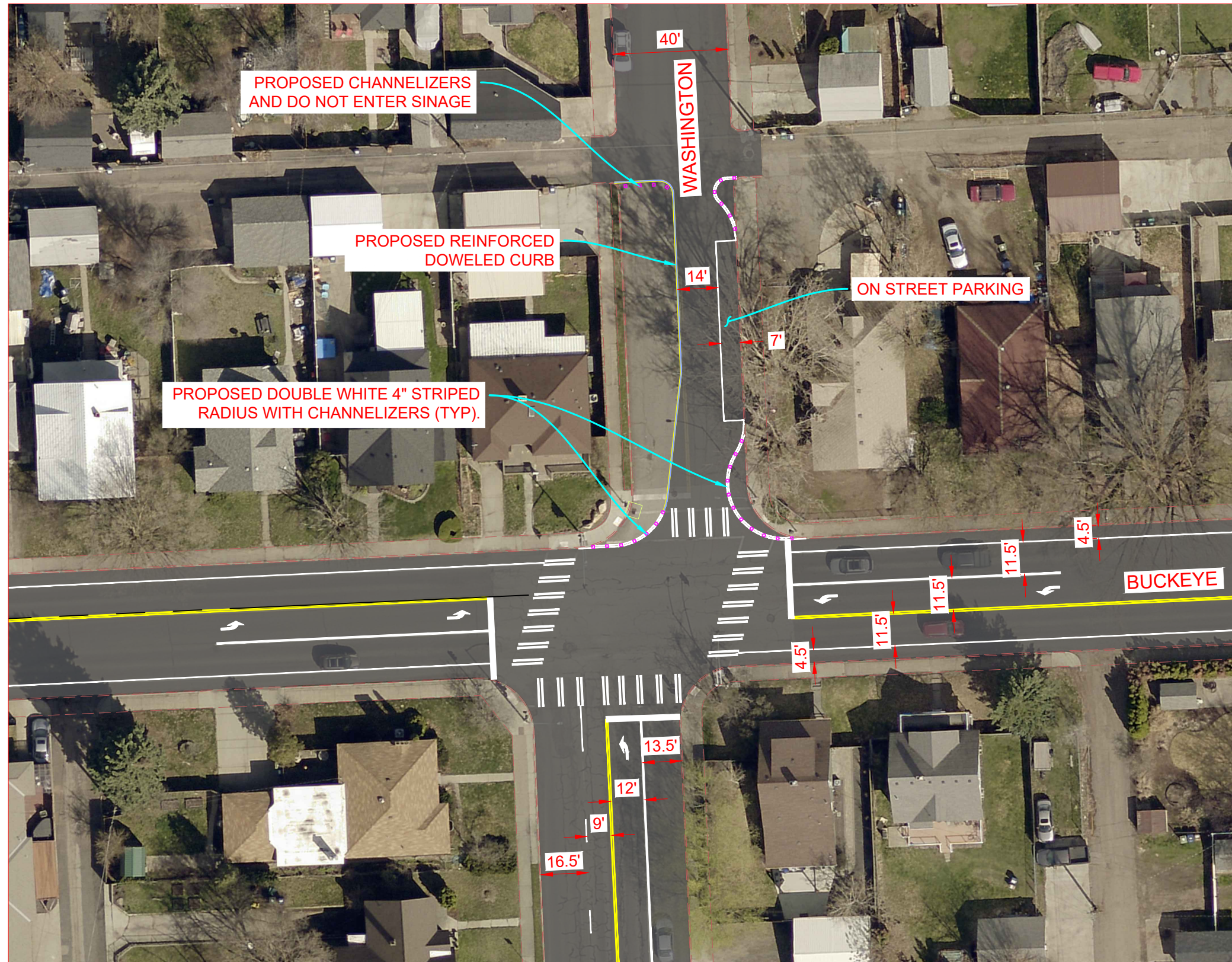

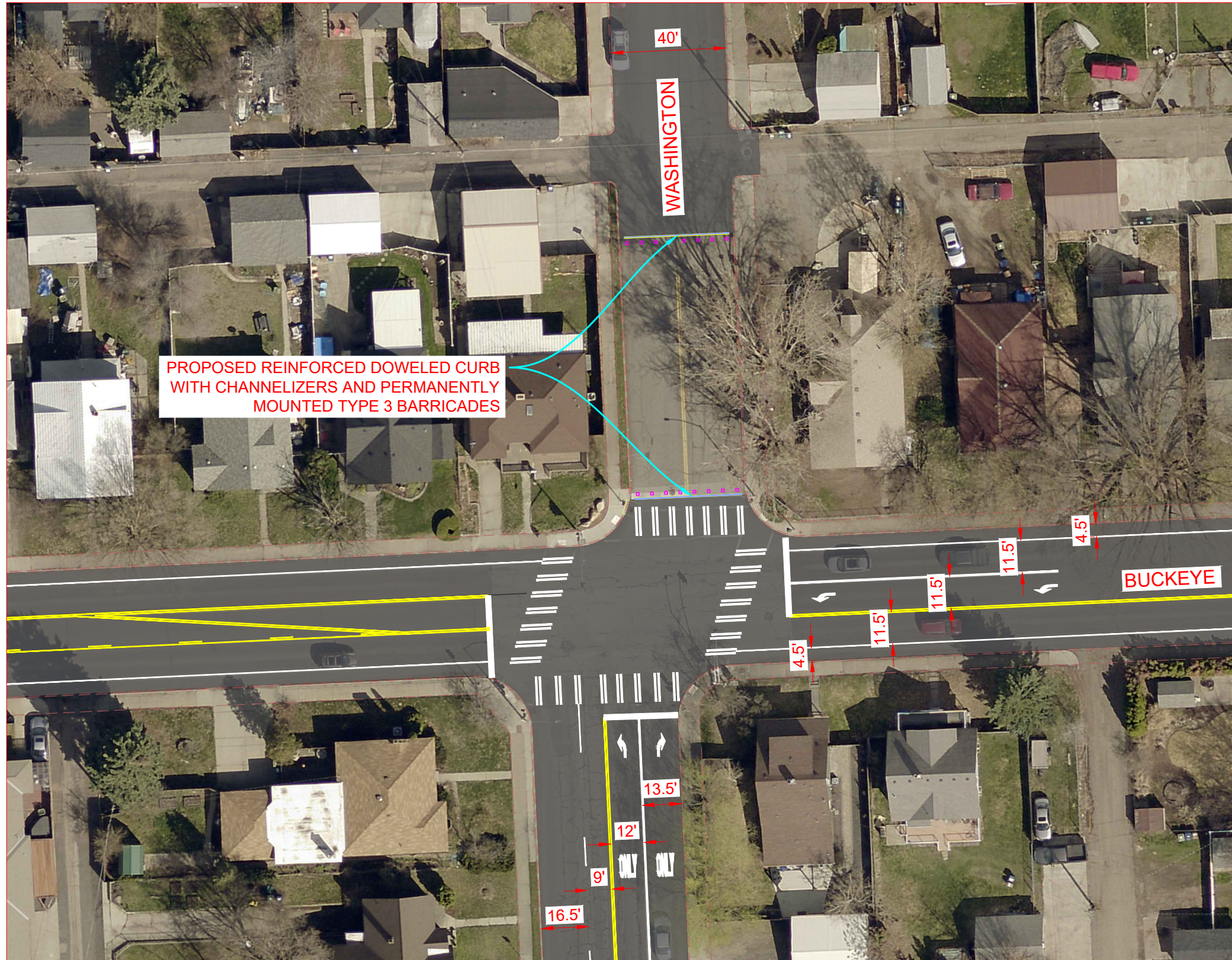
