Northwest Sector Precinct Report: (Officer Ben)

 Officer Ben provided an update on crime and policing in the EG neighborhood and the northwest sector.

Spokane City Council: (Kitty Klitzke)

Council Member Klitzke provided an update on the Washington/Buckeye Street pilot project. She
discussed that they are working to schedule a meeting to gather consensus of what neighbors in

Corbin Park Resident Discussion: (Gina McKenzie)

 Gina, who lives on Corbin Park, discussed that she wanted another opportunity to discuss the Washington/Buckeye street pilot project.

Mansfield Grocery: (Dan Shier)

- Dan Sheir from West Mansfield summarized a bill currently in Washington legislature, HB 1175. This bill allows café and stores to open up in residential zones.
- Eileen confirmed that the EGNC response to the CUP application was submitted timely.

Emerson Garfield Farmers Market: (Anne Luttrell)

 The Farmers Market will be starting June 6. The location has changed to Emerson Park on Madison and Alice Streets. The market will be off the asphalt and the park has a bathroom. The market is looking for volunteers and sponsors.

CDBG funds: neighborhood allocation and grant opportunity

• Eileen provided an update on a funding opportunity for neighborhood projects. Eligible projects for consideration are to make improvements for neighborhood parks. Eligible projects are for construction and rehabilitation but not maintenance and repair. Priority will be given to playground, restrooms, pathway and sport court improvement projects. The city has allocated approx. \$400K of the total CDBG grants for these projects. The projects will be submitted via an RFP process. The application process is March 14. The Council discussed several different project ideas. Several volunteered to draft an application and will meet as a group by the next deadline.
