About the TAC

The TAC provides perspective on transportation issues in a regional forum and develops recommendations on studies, plans, priorities and other relevant documents to aid the SRTC Board of Directors in their decision making. The TAC is comprised of citizen volunteers who represent a broad spectrum of social, cultural and economic backgrounds. The members strive to represent a diverse range of interests that reflect the region and its many communities.

TAC Membership

It is important the TAC reflect the diversity of individuals living in our community. TAC membership should be representative of, and informed by, the various factors that impact the transportation system. To meet this goal, SRTC is seeking applicants who are affiliated with relevant organizations. We are also looking for diverse perspectives from users of the transportation system. Please note that being affiliated with an organization is not required for TAC membership. TAC members cannot be elected officials or members of the SRTC Board.

The term of the initial appointment is through December 2021. Members are appointed by the SRTC Board of Directors and must be residents of Spokane County. The TAC meets as needed, usually monthly.
