



## Emerson-Garfield Neighborhood Council

***Wednesday, June 10, 2020***

The meeting began at 6:03 pm with 13 voting members present. The roster also recorded 2 guests. The May minutes were approved without any changes, with no objections and no abstentions.

We discussed the Parks Committee projects and the need for ideas. We decided to hold our August meeting at Emerson and Corbin Parks. We will meet at Emerson Park at 6 pm, then move to Corbin Park at 6:30 pm. The meeting will begin at 7 pm and will be held at Corbin Park. We will have a chance to discuss ideas for the parks to go into our Parks Plan.

Elections were conducted. Those accepting nominations included:

Voting members voted to approve all nominations.

We voted to approve participation in the parks speed feedback pilot project with 13 yeas, no nays, and no abstentions.

Ideas for [Community Engagement Grant](#) funds were discussed. The 13 members voted to approve to apply for \$100 for an event tablecloth, \$100 for two banners, and split the remaining \$500 evenly between magnets and stickers. We also voted to approve asking for reallocation funds for logoed PPE masks. If masks are not an approved item, we voted to ask for branded color changing pencils.

### Reports

Spokane Public Library – The library is now accepting book returns in their drop boxes. All returned items will be quarantined for a few days. You may begin scheduling curbside pick up of library materials beginning on June 15. [Contact the library for more details.](#)

Clean Up program – The clean up program this year is dump passes only. The City is mailing every resident a \$20 dump pass this year. These dump passes may be combined. There will not be any dump passes available at the Farmer's Market this year.

Community Assembly – There was a lot of discussion about the changes to the clean up program and the lack of input from the neighborhoods. They also discussed the Traffic Calming program applications.

Treasury report – We have \$824.43 in our bank account.
