- The City of Spokane is piloting a new parking payment option in two areas that will have a mobile-payment-only option via a Parking Box. The pilot project will last until the end of 2023. The on-street locations will be 400 S. Washington St., including 13 spaces on the east side of E.L. Hunter Field House, and 300 S. Washington St., four spaces on the east side of Spokane Subaru.
