Good Neighbor Agreement for Jewels Woman's Shelter

Between:

1. Neighborhood council (Emerson/Garfield)
2. Jewels Helping Hands (Homeless service organization operating the woman's shelter)

Location:

Knox Presbyterian Church

806 W. Knox Ave.

Spokane, WA 99205

Purpose:

This Good Neighbor Agreement aims to foster a positive relationship between the neighbors, individuals utilizing the services, and Jewels Helping Hands. The goal is to ensure a respectful, safe, and supportive environment for all parties involved while addressing any concerns that may arise.

Agreement Terms

1. Communication and general understandings:

- All parties agree to maintain open lines of communication. Neighbors can reach out to Jewels Helping Hands with any concerns or feedback regarding the facility or individuals using the services.

- Jewels Helping Hands will provide regular updates to neighbors about the facility's operations and any changes that may affect the community.

- JHH will not provide outside congregate space at this location but will allow scheduled smoke breaks with staff present.

- This location is not a walk in facility. Clients staying on site will be referred through the referral line. (509)824-2312

2. Respectful Behavior:

- Individuals using the services agree to adhere to a code of conduct that promotes respect, safety, and

consideration for neighbors. Rules agreement will be signed between JHH and clients utilizing services.

- Neighbors agree to treat individuals with dignity and respect, recognizing their right to access necessary services.

3. Property Maintenance:

- Jewels Helping Hands will ensure that the facility is well-maintained, clean, and free of litter. JHH will ensure no camping or loitering around the facility. JHH will provide weekly community clean ups in the surrounding neighborhood and will address any people sleeping in the area and help them move to a safer location.

- Individuals using the services will be encouraged to keep the surrounding area clean and to dispose of waste properly.

4. Noise Levels:

- All parties agree to be mindful of noise levels, particularly during early morning and late evening hours, to minimize disturbances to neighbors.

- Jewels. will implement an inside only policy between the hours of 10pm-5am.

- Jewels Helping Hands will implement quiet hours and communicate these to individuals using the services.

5. Safety and Security:

- Jewels Helping Hands will work with local law enforcement and community organizations to ensure the safety of both the facility and the surrounding neighborhood.

- Neighbors are encouraged to report any suspicious activity or concerns to local authorities and Jewels Helping Hands. A 24/7 line of communication will be given to address immediate concerns.

6. Community Engagement:

- Jewels Helping Hands will host regular community meetings to discuss any concerns, share updates, and foster a sense of community.

- Neighbors are encouraged to participate in these meetings and provide input on how to improve the relationship between the facility and the community.

7. Conflict Resolution:

- In the event of disagreement or concern, all parties agree to address the issue directly and respectfully, seeking resolution through dialogue.

- If necessary, a neutral third party may be involved in mediating discussions.

8. Review and Amendments:

- This agreement will be reviewed annually, and any party may propose amendments to improve the relationship and address any emerging issues.
